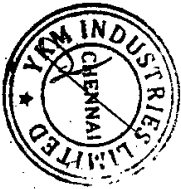

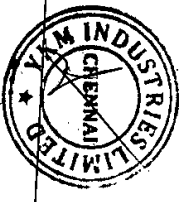

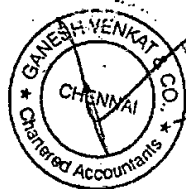

Limited Review Report

To
