Textual Information()	<p>The Company had gone for Offer For Sale in the month of December to attain the Minimum Public Shareholding and for this purpose the Selling promoter, Mr. Anil Jain, had transferred shares (6,06,665 Equity shares) to the account of Keynote Capitals Limited for Offer for Sale which took place on the respective trading days i.e 28th December and 31st December, 2018. But BSE has allotted only 60667 shares to the Retail investors. on the settlement date i.e 1st January, 2019 . Due to this transfer of 606665 shares for OFS, the percentage of holding of the Promoters automatically fell to 75% as on 31st December, 2018 despite the fact that the Selling Promoter owned the Shares as on that date as the Offer for Sale was not complete for the total shares involved. On the suggestion received from BSE, we have to include 606665 shares i.e. 13.51 %, which was transferred for Offer for Sale, to the promoters part in order to file the shareholding pattern, as the shares were transferred merely to follow the OFS procedure temporarily and the same was still in the Name of Mr Anil Jain (the selling Promoter) as on that date. P.S: As on 31st December, 2018, these 606665 shares was lying in the account of Indian Clearing Corporation temporarily for the purpose of OFS.</p>
